FIRST AMENDMENT TO
DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS
PETRINI PLACE, A CONDOMINIUM PROJECT

THIS FIRST AMENDMENT TO THE DECLARATION OF COVENANTS,
CONDITIONS AND RESTRICTIONS, is made this 24 day of January,
2006, by PETRINI PLACE HOMEOWNERS ASSOCIATION, a California nonprofit mutual
benefit corporation (hereinafter "Association").

RECITALS

1. On September 4, 2002, a Declaration of Covenants, Conditions and
Restrictions was recorded in the Office of the Recorder of San Francisco County, as Document
No. H234394, for the Association and its membership, applicable to the real property shown on
the Map described as "Map of Fulton Masonic, a Residential Condominium Project" recorded
the 16th day of August 2002, in Book 75 of Condominium Maps, at Pages 151 through 162,
inclusive, Official Records of the City and County of San Francisco, State of California.

2. Association now desires to make a First Amendment to the Declaration
pursuant to Article 9.4 thereof, as hereinafter provided.

NOW, THEREFORE, Association hereby amends and modifies said Declaration as follows:

1. Article VII, Section 8 is amended to read as follows:

Section 7.8 Floor Covering. Each bedroom (except on ground floor Units and within Townhouse Units) shall be fully carpeted, and all hardwood or hard surface flooring installed in Units must be installed over an acoustical underlayment in accordance with guidelines established by the Association in order to reduce noise and maximize quiet enjoyment of all Owners.


